- 2. **ABC 15 Presentation:** Brittany Schmidt Running Spanish videos though March, so far 100,000 views. Nothing planned in April. The plan for May is to do a Facebook post dealing with monsoon preparedness. There is an opportunity in May for someone to be interviewed as part of a Sonoran Living segment. In June a monsoon season quiz is planned along with an "exclusive partner of the day" that will include a 15-second promotional spot. Estimated cost for this outreach is \$13,500.

- 4. **Fiscal Agent Update**: Andrea Hamilton, Treasurer, reported total expenses for FY18-19, as of January 31st, were \$33,508 with total assets of \$87,703 leaving a bank balance of \$54,195. Expensed last month included website fees and ABC15 outreach. A motion was made by Amy B. and seconded by Eileen to approve the financial report. Voting was unanimous in favor.

- ii. Web Christina Hoppes, Amy Murray
 - Information on the construction training events (March 6th and April 9th) has been posted on the site.
