- 2. **Changes to the STORM Board:** Christina announced that Leigh Padgitt is no longer with Phoenix and will not be able to function as Chair. Christina asked if anyone is interested in serving on the Board to please contact her. She explained that our By-Laws allow her, as Vice Chair, to function as the Chair in the Chair's absence.
- 3. **Review/Approval Meeting Minutes:** A motion was made by Amy B. and seconded by London to approve the meeting minutes of November 27, 2018. Voting was unanimous in favor.
- 4. Fiscal Agent Update: Andrea Hamilton, Treasurer, reported total expenses for FY18-19, as of December 31st, were \$28,571 with total assets of \$87,703 leaving a bank balance of \$59,132. Promotional items (collapsible flask and key-chain carabineer) were received and paid for last month in the amount of \$18,429. All membership dues have been received. A motion was made by Amy B. and seconded by Seandale to approve the financial report. Voting was unanimous in favor.

  Amy B. and London reported the committee had sorted the promotional items (collapsible flask and key-chain carabineer) for the respective member agencies last Thursday. The promotional items were picked up by members today.

- iii. Events Andrea Hamilton, Monica Rabb, Marcella McDonald Monica reminded the group of the two construction outreach events (1. March 6, 2019 at the ADOT Facility; and, 2. April 9, 2019 at Queen Creek) and reported that all volunteer positions are filled. Lonnie volunteered to do a 20-minute presentation on construction BMPs at both events. The committee is still working on other presenters. Andrea asked all agencies to sign up to support the upcoming outreach events. In particular, help is needed at the Tres Rios (March 2-3) and Arizona Game and Fish Expo [at Ben Avery facility] (March 30-31) events.
- Material David Ramirez, David Verhelst, Monica Rabb, Hether Krause Monica reported that the consultant (Gold Street Design) has needed a lot of shepherding. They are in the process of producing two posters (construction and facility maintenance themes) and a new construction flyer.
- V. Digital (videos, ABC15, etc.) Andrea Hamilton, Lonnie Frost, Kellie Elliot, Christina Hoppes

Christina described the efforts of ABC15. They are running the videos on connected TV and have 97,515 impressions with a 98% completion (watched entire video). On Facebook, they have 38,000 impressions with 734 connecting to the STORM site. Brittany (ABC15) is planning to attend next month's meeting with a proposal for the next quarter.

Andrea reminded everyone they should have received a drop box with the three ABC15 videos for their use.

## 6. New Business / Announcements:

a.i. Consideration of Sedona's request to join STORM

Sedona is a Phase II community and have expressed concerns with visitors leaving trash, etc. in the area. They are looking for ways to better educate their residents and visitors. Amy B. suggested that it may be a good idea to send them a sampling of the promotional materials we use. Matt said that there is enough in storage to put together a good sample.

Derek asked if membership is open to others and gave examples of Cave Creek, Care Free, ASU and Cottonwood.

Amy B. asked about fees and the general consensus was to base fees on population.

- a.ii. Christina reminded everyone that STORM needs everyone to participate on committees and at events.
- a.iii. The annual report was discussed with the need for a committee to put the report together. The new format is much more concise and streamlined. Ryan Cavalier volunteered to be on the committee.
- a.iv. Derek said that he had been contacted by Phoenix Dog Magazine about an article.
