2. **ABC 15 Outreach Update:** Brittany Schmidt

The STORM Quiz that recently ran on ABC15's website generated 665 QUIZ SUBMISSIONS. **Quiz** Received Impressions: 33,379, Post Clicks: 52, And A Click Thru: .16%. The ABC/STORM **Facebook Post** for the Quiz had the following statistics: People Reached: 114,989, Post Clicks: 2,799, Link Clicks: 1,768. The associated **Facebook AD** had Impressions: 22,000, People Reached: 20,740 and Post Clicks: 1,350. The Holiday Giveaway Sweepstakes (10 sponsors) will run for two weeks in December to collect additional email addresses. The prize is a \$450 gift card to Arizona Grand Resort.
